6. That the college has already submitted PAR in 2018-19 within stipulated time on dated 31.12.2019. (Annexure IV)

That the college has been issued a final show cause notice by the NCTE WRC by 221946 dated 06.01.2023 received on 24.01.2023 (Annexure IX) to submit a representation supported with documents accompanied by an original affidavit within a period of 7 days from the date of issuance of show cause notice i.e. 13.01.2023 failing which the wrc will take appropriate decision as deemed fit in light of the provisions contained in the NCTE Act. In this regard we would like to emphasize that we have received letter on 24.01.2023 and we replied on the asked matter immediately via mail. (Annexure X)

In terms of NCTE decision we are representing the above said points with supporting documents and kindly see the matter that why we are receiving such letters and final show cause notice even after filling the PAR 2018-19 & 2020-21 within stipulated time.

12. That the copy of the affidavit shall be displayed on the website of the college (www.vipracollege.org) for general public.

13. That the NCTE in its instructions related to filling the PAR has state that the institutions who have filled the PAR(P-2021001225) for the academic session 2018-19 need not to pay the prescribed fee again and are only required to fill the data asked for the academic session 2020-21. Sir/Madam,

With reference to the above, it is to inform you that the Recognition was refused to the institution in its 274th meeting of WRC held on April 22, 2017 for M.Ed. course and letter was issued to the institution on 04.05.2017.

And whereas, institution had filed the Appeal before the Appeal Committee NCTE, New Delhi on 19.05.2017 and regulatory file of the institution forwarded to NCTE Hqrs. New Delhi for appeal on 22.05.2017 and Appeal was decided by the institution on 21.05.2017 and appeal order received in the office on 29.05.2017 appeal order as follows:-

"On perusal of the Memorandum of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for further processing of application.

The Council hereby remands back the case of Vipra Arts Commerce and Physical Education, Raipur, Chhattisgarh to the WRC, NCTE, for necessary action as indicated above."

And whereas, the matter was placed before WRC in its 281st meeting held on September 13, 2017. The Committee resolved as follows:-

"The case file was seen. The WRC in its 274th meeting had refused recognition for the M.Ed. course. The institution filed an Appeal which remanded the case to WRC for further processing. A scrutiny of the documents on record (that one institute has only 2.276 hectares of land for running the existing B.Ed. (two units), P.P.T. (one unit), M.A.Ed. (one unit) Regarding the D.E. Ed course it is clarified that my refusal order was issued on 04.05.2017. This course is not running as stated in the Appeal order. The same is to be used for the current application for the M.Ed. programme.

The land is grossly inadequate for running the above courses. Further, the diverted land only 1300 Sq. Ft. is at the premium paid for diversion upto 2012 only.

An appeal order is given to the institution to submit any other valid documents in this regard before the WRC for its final decision.

Hence, Clarification be issued. Reply will be submitted within one month."

It is to be noted that in the event this office does not receive any reply within 30 days, it will be a presumption that you do not wish to make any representation and the Western Regional Committee will take a decision on the merits of the case.

PUBLIC NOTICE

The National Council for Teacher Education is a Statutory Body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on 17th August 1995 to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

2. As per the provisions of the NCTE Act, 1993 and NCTE Regulations 2014, as amended from time to time, Performance Appraisal Report (PAR) is required to be submitted annually by the existing Teacher Education Institutions (TEIs). Accordingly, NCTE had issued a Public Notice on 22.09.2019 directing all TEIs running NCTE recognised Teacher Education Courses to file PAR for academic session 2018-19. The last date for submission of PAR was 31.12.2019, which was later on extended till 20.01.2020 (Mid night).

3. Aggrieved with the said Public Notice, a number of TEIs approached the Hon'ble High Court of Delhi in W.P. No. 11304/2019 and obtained stay thereon. Hon'ble High Court of Delhi in W.P. No. 11304/2019 pronounced the Judgment on 27.5.2021 upholding the decision of NCTE requiring the TEIs to file PAR. In view of decision of the Hon'ble High Court of Delhi, PAR was required to be mandatorily submitted by all TEIs for the academic session 2020-2021. Timeline to submit PAR was from 29.09.2021 28.01.2022 (mid night) which was later on extended till 15.03.2022.

4. The Division Bench of the Hon'ble High Court of Delhi, vide its Order dated 25 February 2022, while upholding the decision of the Single Bench extended the date of filing of PAR to 31st March, 2022.

5. Thereafter, the Hon'ble Supreme Court, vide its Order dated 01.04.2022 in SLP No. 5479/2022, decided that the TEIs would have to file PAR for the academic session 2020-21 by 2nd April, 2022.

6. The matter was placed before the General Body of the Council in its 54th meeting held on 27th April, 2022 and the Council *inter-alia* decided that with regard to the TEIs which have not filed PAR in compliance with Hon'ble Supreme Court's deadline of 2nd April, 2022, the academic session 2022-23 shall be declared as a zero academic year for fresh intake.

7. In view of the decision taken by the General Body of the Council, appropriate authorities/affiliating bodies concerned are hereby requested to take necessary action accordingly in




